GENERAL NOTICE TO COUNSEL AND JUSTICE SYSTEM PARTNERS Civil Fees and Security Fee Increase Effective July 28, 2009

As a result of the enactment of Senate Bill SBX4 13 (chapter 22, Statutes of 2009), various civil filing fees and the Criminal Security fee will be increased as of July 28, 2009. The additional revenue from the fee increase will be used to offset state budget reductions to trial court operations.

Fee increases apply to the following:

- \$5 increase to first paper civil filing fees (permanent)
- \$10 increase to filings and services authorized in GC sections 70626(a) and GC 70626(b) (permanent)
- \$10 increase to the \$20 security fee authorized by Penal Code section 1465.8 (sunsets on June 30, 2011)

The new civil fees will be reflected on the revised statewide civil fee schedule. The final version of the fee schedule will be posted to the California Courts Web site at www.courtinfo.ca.gov/reference/feeschedule.htm and will also be available at the Santa Barbara Superior Court website at www.sbcourts.org. Please note that the applicable changes are highlighted in yellow.

The \$10 increase to the \$20 security fee authorized by Penal Code section 1465.8 will be reflected on the revised Santa Barbara Superior Court Uniform Bail and Penalty Schedule and will also be available at the Santa Barbara Superior Court website at www.sbcourts.org.
